Junior Golf Personal Conduct Guidelines

A prime objective of our Junior Golf program is to instill in the junior golfer a sense of the traditions and integrity of the game. An important part of this is to conduct oneself in a manner that shows respect for fellow competitors, for your own self and for the golf course. To promote these areas of concern during all Junior Golf activities, the following guidelines will apply.

Safety: During all events, such as, but not limited to, junior classes, junior camps, playing leagues, etc., hold clubs upside down by the club head. Clubs should not be raised above your head at any time or randomly swung out of control. Juniors are not allowed to be in the carts at anytime unless directed to do so by instructor. Juniors should not hang on the sides or back of the carts.

I understand the following will NOT be tolerated:

- Violation of the above stated safety guidelines.
- Conduct detrimental to Le Triomphe Golf & CC
- Use of alcohol or illegal drugs, cheating, abusive language or profanity
- Displays of temper involving throwing or slamming bags, balls, clubs or other equipment
- Abuse of club facilities
- Breach of the USGA rules of golf, poor golf etiquette
- Use of golf carts, unless the players are being shuttled between holes, or at the discretion of officials
